- For calculating the margin under the ceiling for heading 5, account is taken of the footnote (1) of the financial framework 2007-2013 for an amount of EUR 84 million for the staff contributions to the pensions scheme.
- The global margin for the commitments does not take into account the appropriations related to the EGF (EUR 500 million), the EAR (EUR 258,9 million) and to the staff contributions to the pensions scheme.
- The global margin for the payments does not take into account the appropriations related to the EAR (EUR 110 million) and to the staff contributions to the pensions scheme (EUR 84 million).
